







Introduction

- A grant-making facility established to support development of TFCAS in the SADC region
- A culmination of a negotiation process involving the German Government (BMZ), SADC Secretariat and Member States to establish a regional fund for TFCAs.
- The Regional fund to be financed by various International Cooperating Partners (ICPs) in support of SADC TFCAs
- Establishment of the fund is well aligned to Component (2) of the SADC TFCA programme and other SADC Regional Policies and Protocols
- The initial phase of the FFs is funded by the German Government through KfW.







Purpose of the TFCA Financing Facility

- To provide the basis for long-term and more sustainable investment in tangible measures that strengthen ecological, economic, cultural and institutional connectivity within SADC TFCAs.
- The intention is to leverage additional funds from various partners, including further commitment from Germany, in order to reach an operational funding volume of approximately EUR 100 million in the medium to long term.







The SADC TFCA Financing Facility


- Initial phase of the project: 6 years (April 2020 June 2026).
- Initial budget of €12m, with an additional commitment of €11m from KfW
- In the lifetime of the 6 years it is anticipated that 10 20 grants will be awarded;
- The size of individual projects is expected to range between €300,000 -€3m in the form of large/medium/small grants – subject to approval by SC.
- A number of agreements were signed between SADC & German Government and between SADC & IUCN on the 5th November 2019; 17th of December 2019 and 3rd of July 2020 respectively - paved way for the Inception phase of the TFCA FF.

Implementation Modalities

- IUCN Eastern & Southern Africa Regional Office (ESARO) is the Executing Agent for TFCA FF
- IUCN is setting up a PMU based in Pretoria, South Africa.
- A Steering Committee (SC) for the project is now in place (comprising of SADC TFCA Member States and ICPs)

Subject to further assessment of staffing needs and approval by the SC, the following positions are proposed for the PMU


- Team Leader

Inception Phase

 - Inception work plan & budget
